This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 83497). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The applicant proposes to subdivide approximately 30 acres into 163 single family residential lots in the MU-N (mixed use - neighborhood) zone. Lots within the subdivision would range in size from 4,785 square feet to 14,234 square feet. Access to the subdivision would be from Avenue I and all streets within the subdivision would be private.

Location: The project site is located on approximately 30 acres on the north side of Avenue I at 42nd Street West in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Numbers (APNs) 3105-018-014, -044, -045, and -046.

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, hazards/hazardous materials, noise, and traffic/transportation.
