The City of Beverly Hills is the Lead Agency under the California Environmental Quality Act (CEQA) and will be responsible for preparing an Environmental Impact Report for the remaining portion of the proposed Robertson Boulevard Sidewalk Improvement Project as described below and an accompanying Robertson Boulevard Street Tree Master Plan (herein referred to as "RSTMP"), collectively the "Project".

The purpose of this notice is to extend the public comment period to solicit comments on the Notice of Preparation. The initial 30-day comment period scheduled from Wednesday, December 20, 2023 to Friday, January 19, 2024, at 5:00 p.m., is **now extended until Wednesday, February 28, 2024 at 5:00 p.m.**

EXTENDED REVIEW PERIOD FOR NOTICE OF PREPARATION DEADLINE: Wednesday, February 28, 2024 at 5:00 p.m.

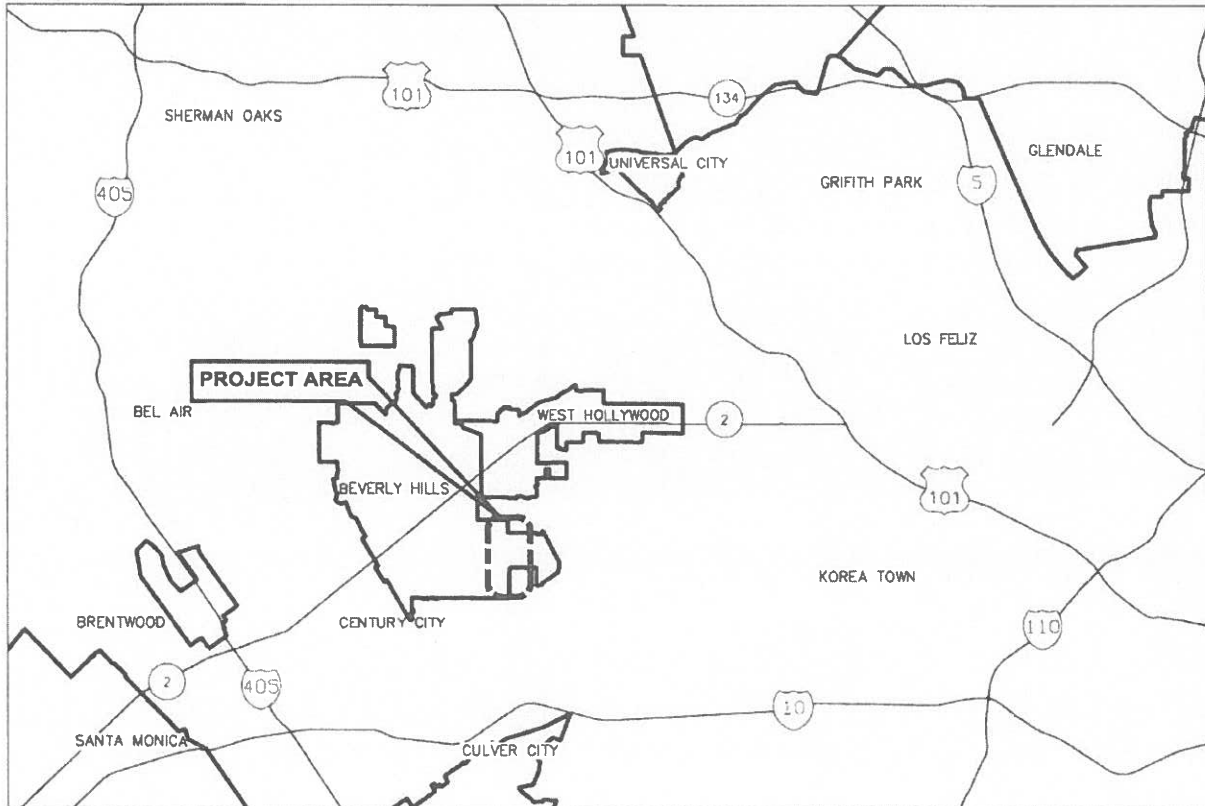


FIGURE 1: Project Vicinity Map

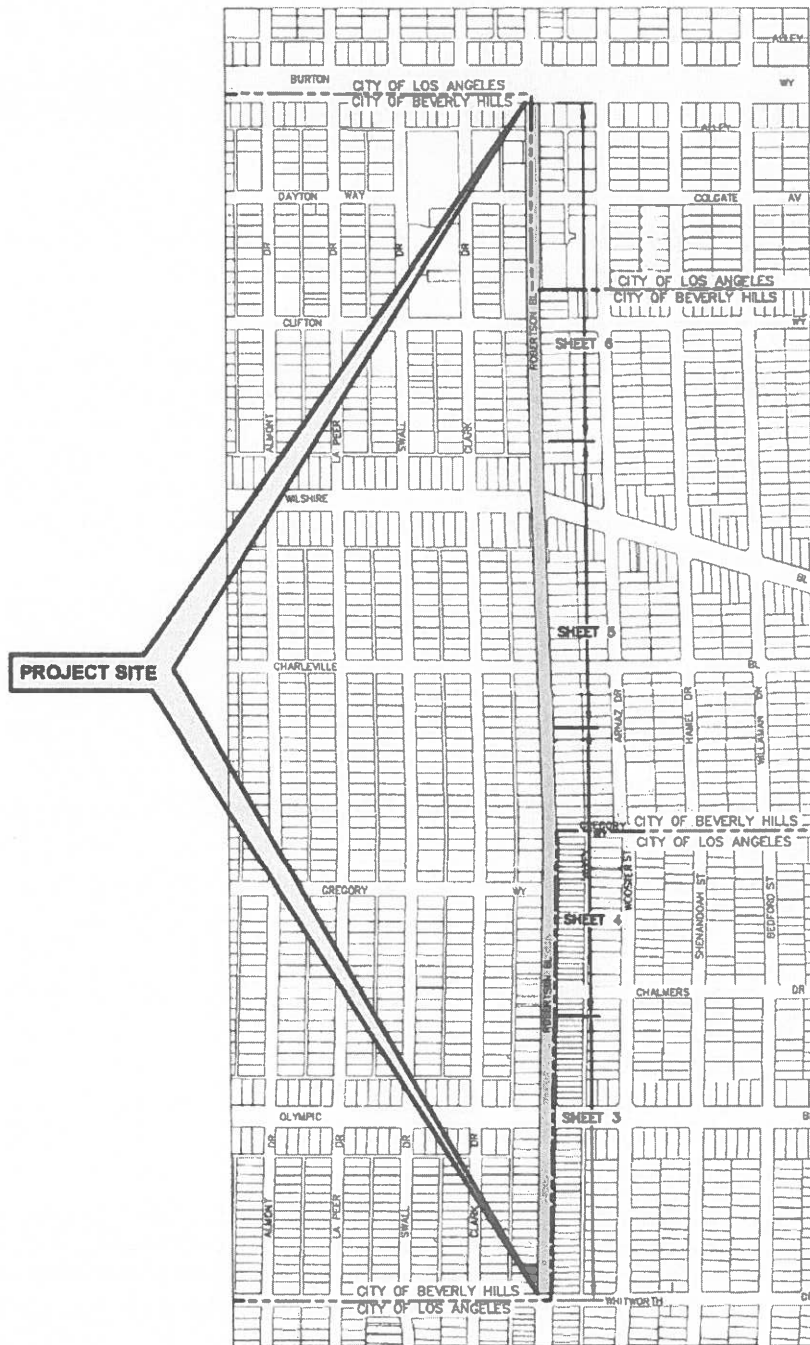


FIGURE 2: Project Site

Project Location: The Project site, for purposes of the RSTMP consists of the six blocks of Robertson Boulevard in the City of Beverly Hills. Specifically, the Project site to be encompassed in the RSTMP is bordered by Burton Way to the north and Whitworth Drive to the south and encompasses approximately one mile of Robertson Boulevard. The proposed Robertson Boulevard Sidewalk Improvement will occur within the RSTMP area, and specifically on the east side of Robertson Boulevard between Charleville Boulevard and Gregory Way, and on the west side of Robertson between Gregory Way and Whitworth Drive. Figure 1 shows the boundaries of the City in a regional context. Figure 2 illustrates the Project site.

The Project site is approximately eight miles west of the City of Los Angeles City Hall and four miles northeast of the City of Santa Monica. Local access to the Project site is provided by Wilshire Boulevard, Olympic Boulevard, Whitworth Drive, and Gregory Way, with regional access provided by Interstate 405 (I-405) and Interstate 10 (I-10).

Project Description: The Project consists of replacing over 64,000 square-feet of damaged sidewalk along six blocks (roughly 1.0 mile in length) of Robertson Boulevard to provide safe, accessible, and long-lasting infrastructure for pedestrians. Associated work includes replacement of curb and gutter, driveway and alley approaches, and ADA-compliant curb ramps. Other work includes installation of stormwater quality bioretention units, tree lighting and electrical outlets, irrigation system and utility adjustments. Trees that will present a significant likelihood of failure will be replaced in accordance with

a newly proposed RSTMP. The remaining work to be completed as part of the Project is on the east side of Robertson Boulevard between Charleville Boulevard and Gregory Way, and on the west side of Robertson Boulevard between Gregory Way and Whitworth Drive. It is expected that 36 trees along these sections of Robertson Boulevard will be removed and replaced during the sidewalk repair. The RSTMP will be utilized as an evaluation method for determining the possible removal and replanting of trees along the aforementioned blocks of sidewalk.

Study Areas: The City, as the Lead Agency, is responsible for environmental review under CEQA. Using the CEQA Guidelines Appendix G Environmental Checklist as a guide, the following areas of potentially significant environmental impacts are anticipated to require analysis in the Draft EIR:

- Aesthetics
- Air Quality
- Biological Resources
- Greenhouse Gas Emissions
- Land Use and Planning
- Noise
- Mandatory Findings of Significance

Potential cumulative impacts and potential for growth inducement will also be addressed. Project Alternatives, including the No Project Alternative, will be evaluated. The Project site is not located on the State Department of Toxic Substances Control Hazardous Waste and Substances Sites (Cortese) List.

Comment Period: The City invites written comments on issues related to potential environmental impacts during the comment period. The initial 30-day comment period scheduled from Wednesday, December 20, 2023 to Friday, January 19, 2024, at 5:00 p.m., is **now extended until Wednesday, February 28, 2024 at 5:00 p.m.** . Separate notices for the Notice of Availability of the Draft EIR and the City Council hearing for the Project will be released at later dates.
