PROJECT LOCATION-SPECIFIC: The project is located at 8305 Calle Del Cielo, La Jolla, CA 92037.

PROJECT LOCATION-CITY/COUNTY: San Diego/San Diego

DESCRIPTION OF NATURE AND PURPOSE OF THE PROJECT: Site Development Permit (SDP) and Coastal Development Permit (CDP) to demolish an existing 4,545 square foot single family residence and attached garage and construct a new 11,754 square-foot single family residence. In addition to the residence the project would construct a 733 square-foot garage and a 1,391 square-foot detached four car garage, and also a sports area. The 0.68-acre site is located in the LJSPD-SF Zone and the Coastal (Non-App) Overlay, Coastal Height Limit Overlay, and Coastal (Non-Appealable) Overlay Zones in the La Jolla Community Planning Area and Council District 1. The project complies with all height and bulk regulations and is located on a site that is currently developed with the public utilities in place to serve the facility.

REASONS WHY PROJECT IS EXEMPT: The City of San Diego conducted an environmental review and determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15302 (Replacement or Reconstruction). The exemption allows for the replacement of existing structures with new ones and where the structures would be located on the same site and would have substantially the same purpose and capacity. Since the project would replace one residence with another residence the project qualifies to be categorical exempt from CEQA. Additionally, the site is located in an area where public services exist, is devoid of sensitive resources, and the exceptions listed in CEQA Section 15300.2 do not apply.
