The applicant is requesting approval of Tentative Parcel Map (TPM) 80287. The proposed TPM would subdivide the existing 19.87-acre parcel and would create four new lots. Two lots would be accessed from Triumph Avenue and two lots would be accessed from Tannahill Avenue. A single-family home could be developed on each newly created lot in the future, but no new development is being proposed with this request. No oak trees on site would be removed as part of this subdivision.
