Description of Nature, Purpose, and Benefits of Project:	
The goal of this project is to create habitat for nesting birds, pollinators, amphibians and small mammals, as well as sequester carbon, remove hazardous fence that has previously injured wildlife and filter run-off from the county road before it enters the watershed. The project includes removing non-native invasive species and establishing a 730 ft hedgerow bordering areas of crop production and pasture, in addition to a 140 ft bioswale that will capture road runoff and provide seasonal wetland habitat for amphibians. This project will also cut down old barbed wire fencing that has entrained wildlife in the past in a sensitive riparian area. This project will enhance native pollinator habitat and nesting bird habitat in an area that was previously dominated by invasive species. Laying down hazardous fencing will reduce the chance of wildlife injury and death, and increase access to a seasonal creek and pond. The planting palette will reduce the vulnerability of wildlife to phenological mismatches by increasing the number of months and amount of resources (food, cover) that are available.
