Project Location: The Project is located at 3220 S. Halladay Street, Santa Ana CA 92705, in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution and Manufacturing License submitted on 4/12/2021 and 05/12/2021, respectively, by Keith Scott II. ROYAL M&D LLC applied for a distribution license out of an existing facility located at 3220 S. Halladay Street, Santa Ana CA 92705 (APN 411-151-02). The applicant will store cannabis products for distribution and manufacturing in 3,900 square feet of 8,000 square foot facility.

Project Activities:

The Project will consist of 3,900 square feet of distribution and manufacturing activities. The project will not expand the existing facility and interior and exterior tenant modifications proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building which was formerly used as a machine shop with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
