SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108

Project Title: Streambed Alteration Agreement No. EPIMS-ELD-46390 (Dug Timber Harvesting Plan 4-21-00105-ELD, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in El Dorado County, within CALWATER watersheds Ceder Creek, Farnham Creek, Oregon Gulch, Sopiago Creek, and their connecting tributaries; Township 8N, Range 13E, Sections 2, 11, 13, and 23-25 and Township 8N, Range 13E, Sections 7 and 18, U.S. Geological Survey (USGS) Quad Maps Omo Ranch and Aukum; Mount Diablo Base and Meridian.

Project: The nine projects are limited to the maintenance of water drafting sites, water drafting, replacement of an undersized culvert, and installation of a temporary vented ford. Further explanation of work can be referenced within the THP 4-21-00105-ELD.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration / negative declaration / timber harvesting plan prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
