Project Title: Cannabis Cultivation (Project).

Project Location: The Project is located at 8516 Fruitridge Road in Sacramento, CA 95826 (APN 062-0090-032-0000).

County: Sacramento

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Cultivation License submitted on 08/15/2019 by River Tree Enterprises.

Project Activities:

Project is located at 8516 Fruitridge Road Sacramento, CA 95826 on APN 062-0090-032-0000. Activities include cannabis cultivation on a 1.6 Acre lot in an existing 39,000 square foot (sf) warehouse in the Heavy Industrial (M-2S) zone. The applicant proposes to partition the building into two suites (Suite A – 26,120 s.f. and Suite B – 12,900 s.f.) to cultivate cannabis within the entire building. The applicant proposes interior modifications in order to grow the plants and only a minor modification to the exterior of the building to add additional lighting and necessary mechanical equipment.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building which was formerly used as a manufacturing and wholesale uses building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
