**Project Title:** Long Beach Utilities Department/Los Angeles Department of Water and Power Haynes Generating Station Recycled Water Pipeline Project

**Project Location** (include county): The project site begins at the intersection of Atherton Street and Studebaker Road in Long Beach, CA 90815 (Los Angeles and Orange Counties). The Project continues south, following Studebaker Frontage Road, Studebaker Access Road / State Route 22 off-ramp and east along College Park Drive over the San Gabriel River, in Long Beach. The Project continues east across College Park Drive into Seal Beach, CA 90740 and continues south beneath State Route 22 to the Los Angeles Department of Water and Power (LADWP) Haynes Generating Station in Seal Beach.

**Project Description:** The Project consists of constructing a contiguous recycled water (RW) pipeline to serve LADWP's Haynes Generating Station located in the City of Long Beach. The Project would be constructed within previously disturbed areas supporting numerous existing structures and subsurface utilities, City and State roadways, and associated surface improvements (i.e., paving, landscaping, and above-ground utilities). The RW pipeline would be constructed within the existing roadway right-of-way. The majority of the RW pipeline would be installed via the traditional method of open-cut trenching. A small section of the Project would be placed within a micro-tunnel steel casing that would be constructed under SR 22.

**Environmental Review:** An Initial Study/Mitigated Negative Declaration (IS/MND) was prepared for the proposed Long Beach Utilities Department/Los Angeles Department of Water and Power Haynes Generating Station Recycled Water Pipeline Project (SCH # 2024010488).


