Description of Nature, Purpose, and Beneficiaries of Project: The Applicant proposes to construct one (1) manure separation system, including sand separation infrastructure, a mechanical separator, and stacking slab. Additional infrastructure is proposed for wastewater flow feasibility and for the transfer and return of waste to and from an Anaerobic Digester located on 15417 Avenue 104. The beneficiaries of the project would be the citizens of Tulare County.
