Project Title: Easement to San Diego Gas & Electric for Electrical Facilities at National City Marine Terminal

Project Location – Specific: Quay Avenue, National City, CA 91950

Description of Nature, Purpose, and Beneficiaries of Project: The proposed project is an Easement Agreement (Agreement) to San Diego Gas & Electric (Grantee) for their use of approximately 4,349 square feet (sq ft) of land area located on Quay Avenue between W 28th Street and W 32nd in the city of National City, California. The area proposed for use under this Agreement is currently and would be used only and exclusively to excavate for, lay, erect, construct, build, install, modify, improve, rebuild, reconstruct, relocate, reconfigure, repair, replace, substitute, change the size of, upgrade, maintain, patrol, inspect, test, operate, use and remove facilities consisting of underground facilities for the transmission and distribution of electricity and related public utility purposes, together with all fixtures, equipment and appurtenances necessary or convenient for the maintenance, operation and use thereof (collectively, "Facilities"). The Agreement further grants the Grantee and its authorized agent(s) and contractor(s) the right of ingress and egress to, from, and along said easement area via practical routes across the adjacent District lands. The Grantee may be required to demolish any or all facilities, structures, installations, or improvements within thirty (30) days after the expiration of the term of the Agreement or sooner.

It is anticipated that the Agreement would have a total term of approximately seventeen (17) years. The Agreement may be terminated by the District as a matter of right and without cause at any time upon providing ninety (90) days' written notice to Grantee of such termination.



Reason Why Project is Exempt: The proposed project is determined to be Categorically Exempt pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (Existing Facilities) and Section 3.a.(4) of the District's Guidelines for Compliance with CEQA because it consists of an easement agreement for existing electrical facilities located at National City Marine Terminal. There would be no expansion of use beyond previously existing, would not result in a significant cumulative impact due to the continuation of the existing use, and no new development is authorized as part of the new easement agreement. Section 3.a.(4) of the District's CEQA Guidelines is as follows:

3.a. **Existing Facilities:** Includes operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing, including but not limited to:

- (4) New and renewed short-term tenancy agreements which do not result in change in the existing use. This exemption does not apply to any new development associated with the activities of the tenant. This exception is also inapplicable if the cumulative impact of continuing the existing use or conditions in the same place, over time, is significant.
