FAY HILL PIPELINE RELOCATION PROJECT

Overview and Background

The Fay Hill Pipeline Relocation Project (Project) will replace approximately 580 feet of existing 12-inch steel pipeline with new 12-inch steel pipeline within EBMUD's Right-of-way (RW) 1978, located along Fay Hill Road in the Town of Moraga.

In 2018, the 12-inch Fay Hill Pipeline was installed as part of the Summerhill Homes development project. Segments of the pipeline were installed at elevations that do not meet the original design intent and impede normal reservoir operation. This Project will lower the pipeline alignment in these high elevation segments.

Project Purpose and Objectives

The purpose of the Project is to replace two high elevation pipeline segments of the existing Fay Hill pipeline and install the replacement pipeline sections at a deeper elevation to provide necessary operational flexibility of the water distribution system.

Project Location

The Project is located within EBMUD's R/W 1978 along Fay Hill Road in the Town of Moraga. Refer to Figure 1 for the project location.

Project Characteristics

The Project includes the removal of 580 feet of existing steel pipeline and the installation of two segments (240 feet and 340 feet) of 12-inch steel pipeline. The pipeline will maintain the same alignment but will be installed at a lower elevation.

Permits and Approvals

All work will be on EBMUD RW 1978. Encroachment permits are not required since there is no work within the public RW. Any necessary permits from regulatory agencies will be obtained to complete the Project.

Public Considerations

For most of the Project duration, the pipeline will be shutdown to perform the pipeline construction work, however no water service disruptions are expected. Due to potential

operational constraints under higher water demands, EBMUD will limit the pipeline shutdown to the months of December through March when water demands are lower.

Standard environmental and safety practices applicable to all EBMUD construction projects have been incorporated into the Project. These standard practices minimize impacts to the public resulting from EBMUD construction projects.

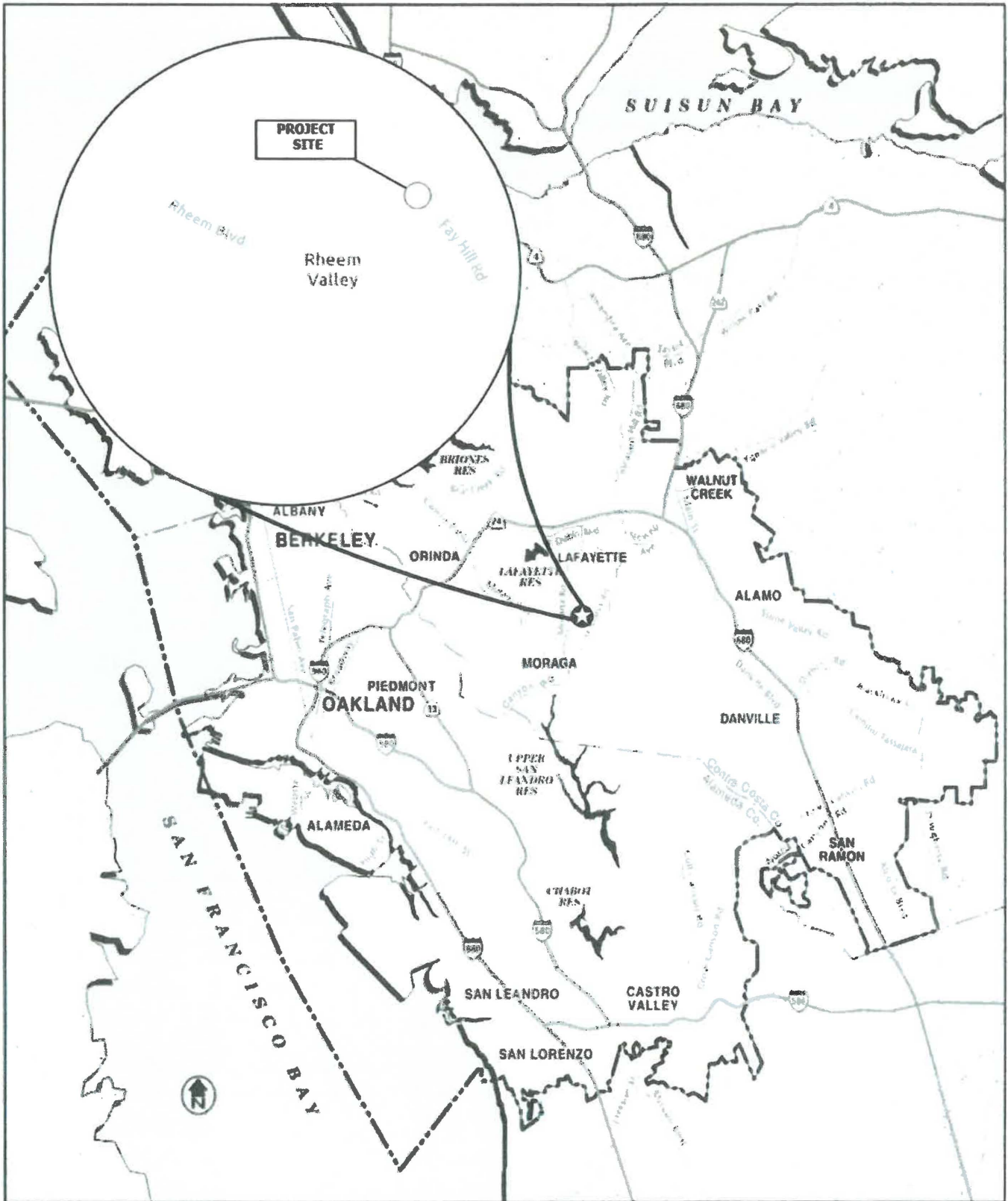
Schedule and Work Hours

Construction is anticipated to start in 2025 and last approximately two months. Construction activities will be limited to the daytime weekday hours (8:00 a.m. to 5:00 p.m.).
