## **Reasons Why Project is Exempt:**

The Board has determined that the project is exempt under the Class 3 New Construction of Small Structures categorical exemption (CEQA California Code of Regulations, Title 14, Section 15303) because the proposed activity consists of extension of public utility power lines and the installation of poles to serve the public. The project is also exempt under the Class 4 Minor Alteration to Land categorical exemption (CEQA California Code of Regulations, Title 14, Section 15304) because the proposed activity consists of minor fill and excavation related to installation of the public utility poles. The project is also exempt under the Class 1 Existing Facilities categorical exemption because the proposed activity consists of the expansion of an existing utility line.
