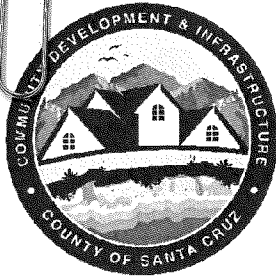

Project Name: CC151-CC150 Emergency Sewer Repair
Project Location: The project is located along the southern parcel boundaries of 5606 and 5630 Soquel Drive and a portion of the adjacent parcel to the south (2613 Monterey Avenue) in Soquel.
Assessor Parcel No.: 037-191-13; 037-191-18; 037-191-38; 037-161-20
Project Applicant: Santa Cruz County Sanitation District
Project Description: The Project involves replacement of approximately 450 linear feet of existing broken and damaged public sewer lines with new high-density polyethylene (HDPE) pipe. Through routine video inspections of the sewer pipe, maintenance crews identified that the vitrified clay pipe (VCP) in this location is broken and needs immediate repair to maintain service and prevent a spill near the adjacent drainage gulch. The majority of the pipe (356 feet) will be replaced using a trenchless construction method called pipe bursting to minimize ground disturbance and excavation. Approximately 44 feet of pipe will be replaced using conventional open-cut trenching, and an approximately 50-foot steel pipe, supported by a steel bridge spanning across a drainage channel, will be removed and replaced with a new metal pipe with HDPE pipe running through it. All work will occur outside of the bed and banks of the drainage channel.
