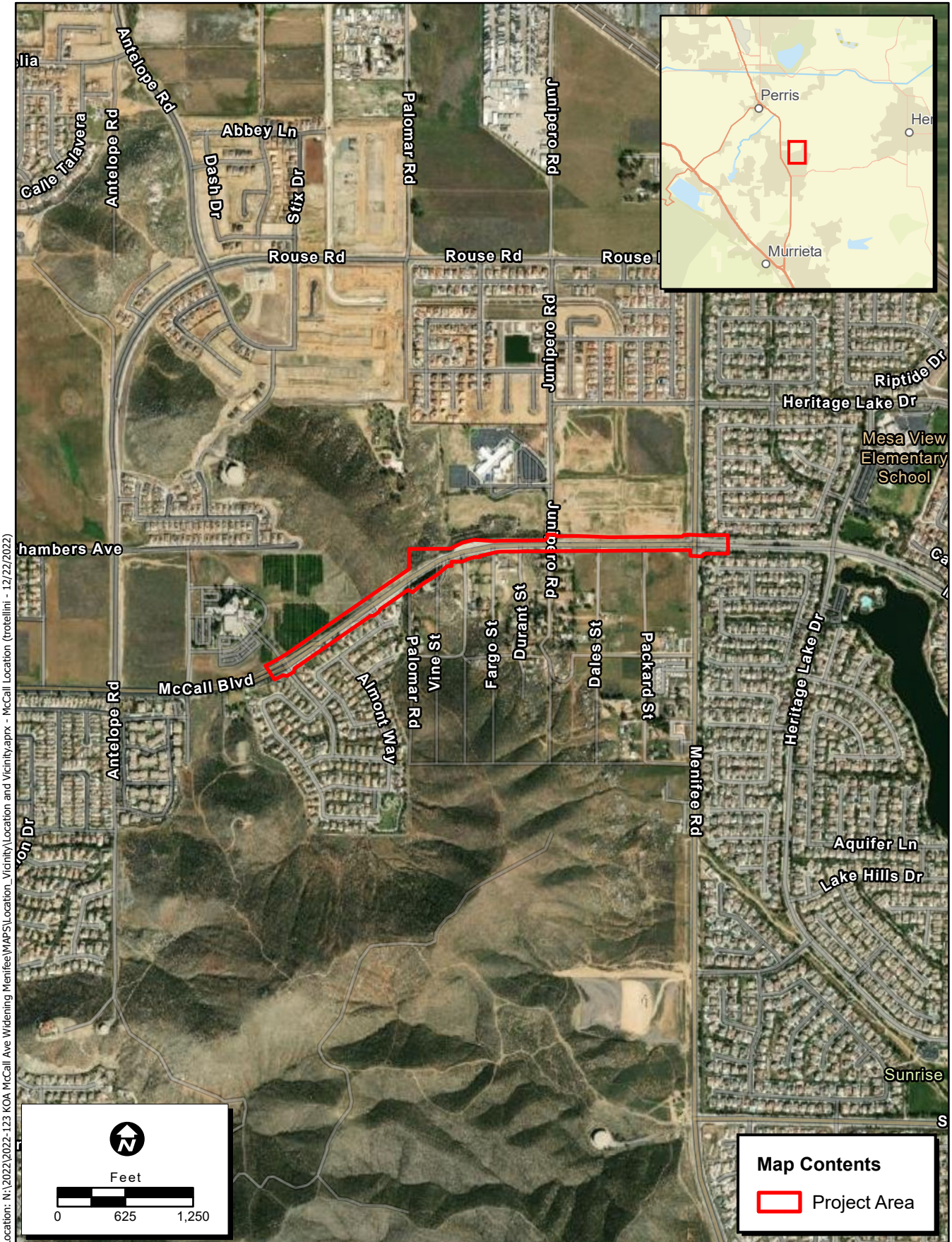

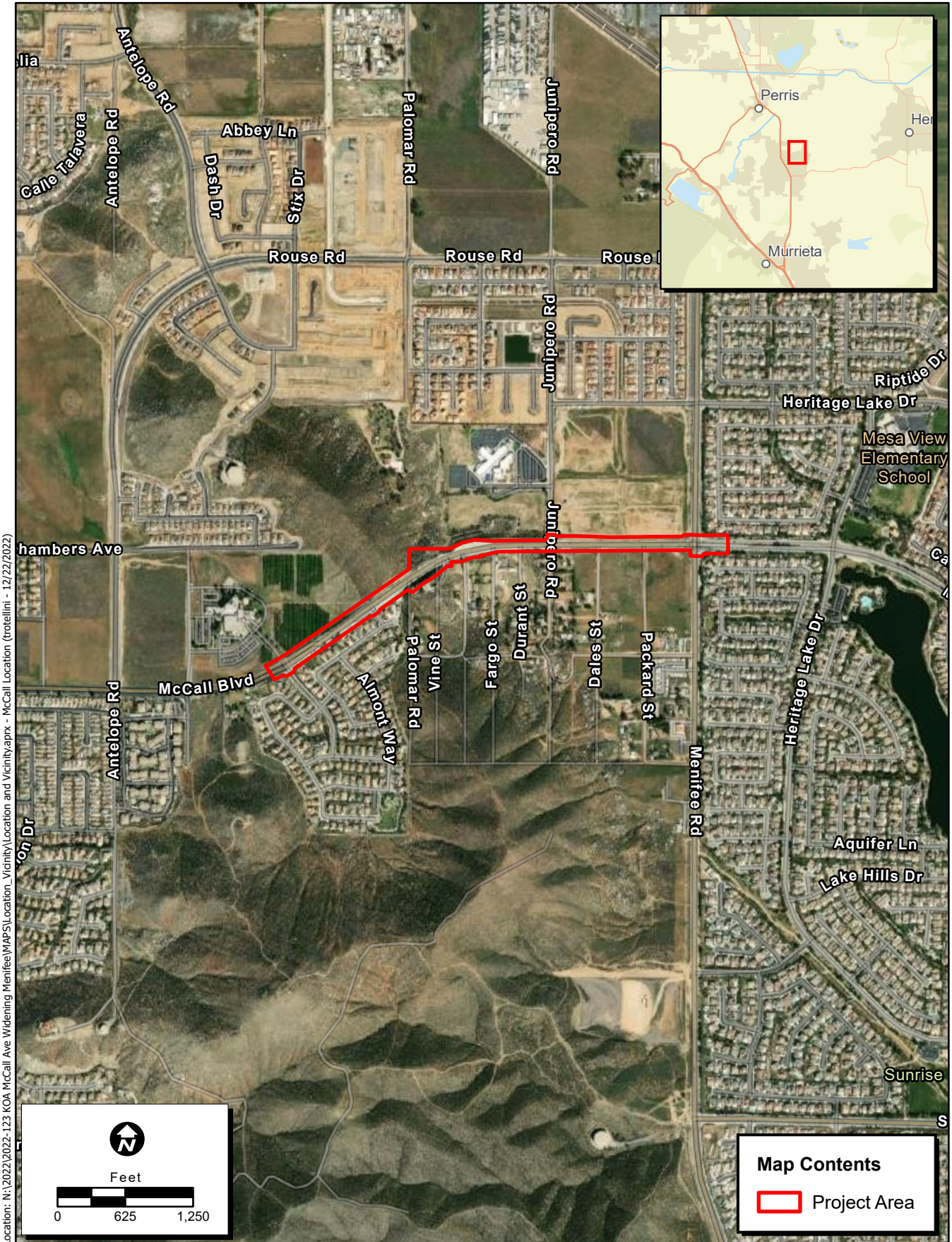

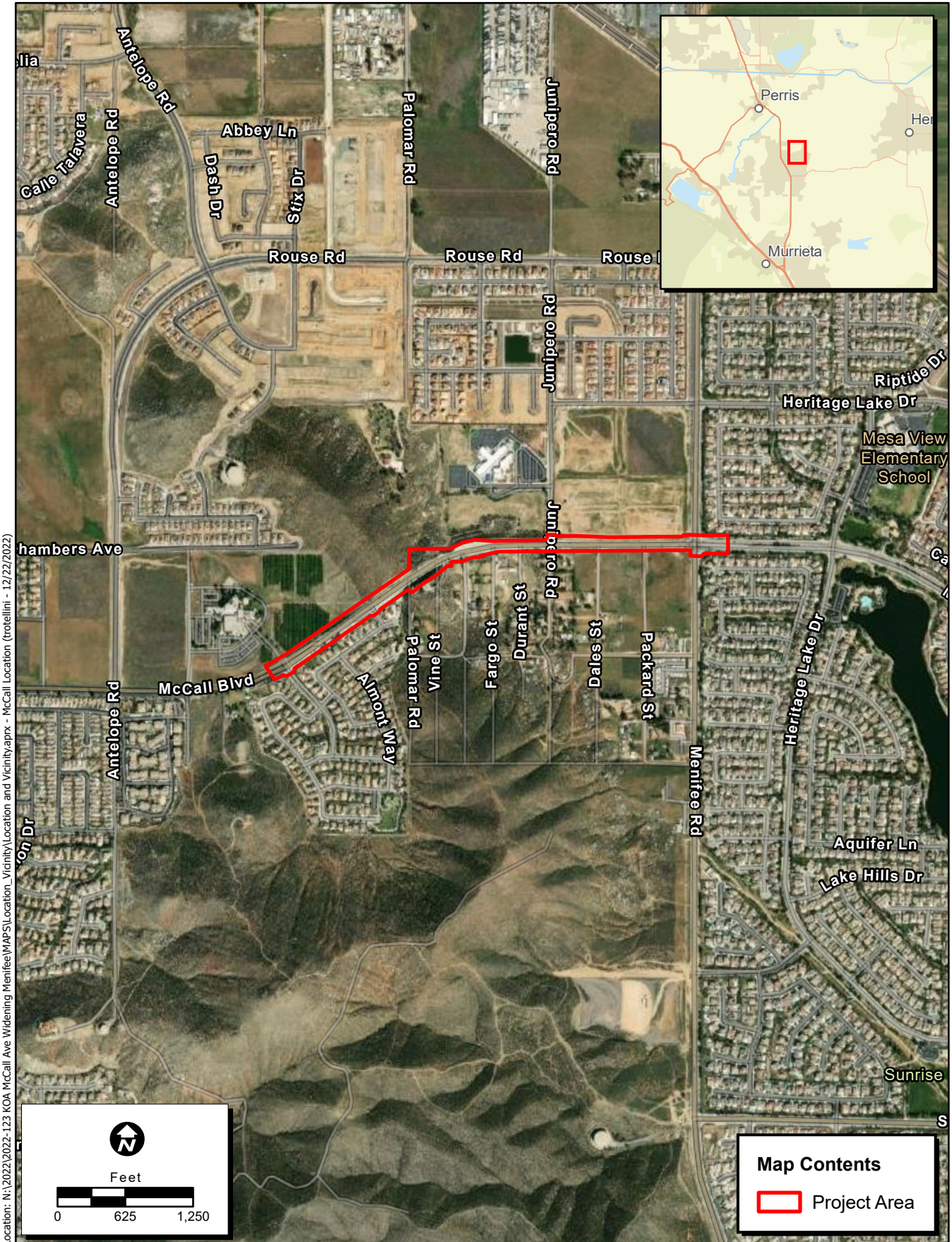

**Meeting Notes:**

Diego shared improvement plans for the McCall Blvd Project from Oakhurst Ave to Juniper Rd. All proposed work will be inside the city right of way. Proposed activities are road widening, adding retaining walls, and cutting down slope to minimize wall height. Modify traffic signals at Oakhurst and Juniper. Will be getting some right of ways in some sections. Lacy confirmed that ACBCI did receive the documents and Clarista is the Analyst in charge for this project. Sherry discussed minor improvements and grading for the project. ACBCI brought up the existing archaeological site and inquired about any potential new impacts and stated the hills to the south are considered sensitive for the Luiseño. Sonia stated the site record for the archaeological site was included in Appendix D of the cultural report. Diego/Sherry used Google Earth to show the majority of the archaeological site boundary is behind a fence line and went over the existing impacts already taken place prior to the upcoming project. It was stated that there will be minimal additional impacts of the area in question for the upcoming project. Diego also confirmed no work will extend south into the hills in question. ACBCI agrees with the stated COA and defers monitoring to Pechanga and Soboba; however, wants to be consulted with any new finds and copies of new documents to be sent to the tribe for review.

**Summary:** No major concerns with the proposed COA by ACBCI and they defer monitoring to Pechanga and Soboba. Requests any new finds and new documents associated with the project that ACBCI be notified.

This letter is written on behalf of the Pechanga Band of Indians (hereinafter, "the Tribe") a federally recognized Indian tribe and sovereign government in response to the AB 52 notice provided by the City of Meniffee.

This email serves as the Tribe's formal request to begin consultation under AB 52 for this Project. Per AB 52, we intend to assist the City in determining the type of environmental document that should be prepared for this Project (i.e. EIR, MND, ND); with identifying potential tribal cultural resources (TCRs); determining whether potential substantial adverse effects will occur to them; and to develop appropriate preservation, avoidance and/or mitigation measures, as appropriate. CEQA, as amended by AB 52, requires the City to avoid damaging effects to the significance of a tribal cultural resource. As such, the preferred TCR mitigation is complete avoidance and the Tribe requests that all efforts to preserve sensitive TCRs be made as early in the development process as possible.

Please add the Tribe to your distribution list(s) for public notices and circulation of all documents, including environmental review documents, archaeological reports, development plans, conceptual grading plans (if available), and all other applicable documents pertaining to this Project. The Tribe further requests to be directly notified of all public hearings and scheduled approvals concerning this Project, and that these comments be incorporated into the record of approval for this Project.

The Pechanga Tribe asserts that the Undertaking is a part of ‘*Atáaxum* (Luiseño) territory, and therefore the Tribe’s aboriginal territory as evidenced by the existence of cultural features associated with religious practice and an extensive artifact record in the vicinity of the Project. This culturally sensitive area is affiliated with the Pechanga Band of Indians because of the Tribe's cultural ties to this area as well as our extensive history with the City and other projects within the area.

As you know, the AB 52 consultation process is ongoing and continues until appropriate mitigation has been agreed upon for the TCRs that may be impacted by the Project. As such, under both AB 52 and CEQA, we look forward to working closely with the City on ensuring that a full, comprehensive environmental review of the Project's impacts is completed.

In addition to those rights granted to the Tribe under AB 52, the Tribe reserves the right to fully participate in the environmental review process, as well as to provide further comment on the Project's impacts to cultural resources and potential mitigation for such impacts.

The Pechanga Tribe looks forward to working together with the City of Menifee in protecting the invaluable Pechanga cultural resources found in the Project area. **Meeting Notes:** Mr. Guillen started with a short introduction of the key personnel for the meeting. Ms. Nour began with a discussion of Project site plans and Project location, and updates that the Project IS/MND is currently undergoing the revision process. Ms. Nour provided an in-depth overview about the limits of project-related proposed impacts, including re-grading, limited to the westbound of McCall Blvd. Highlight proposed retaining wall installation to minimize re-grading impacts and keeping within the existing disturbance of McCall Blvd. Google Earth used to show the current impacts as they are limited to within the current right-away and disturbance within McCall Blvd and some of the area of proposed impacts to Junipero Road. Eastbound McCall Blvd will undergo some improvements but not extensive as westbound.

Mr. Guillen asked Pechanga about questions or comments. Ms. Earp asked to review site plans near Fargo and Ms. Nour highlights this area as keeping within current pavement overlay. Ms. Earp highlights the known resource area in the Project Area and requests the CAD files so the Tribe can compare with their data. Ms. Earp then asked about last when widening and grading; exact date is unknown and Mr. Guillen states he will look up to provide. Question regarding the current SCE poles, about four-five poles, that will be relocated by Edison, mostly behind retaining wall along McCall. Edison will provide final relocation locations. Inquiry about southern roads, grading and widening with then asphalt and gravel base to be placed. Ms. Earp requests a field visit to look at southern roads, due to scheduling conflicts, most likely in September. Ms. Ozdil requested to remove curation language and to determine the reburial location(s) at a later date. Mr. Macarro states the Tribe doesn't have any current GIS data for the known resource but mentions numerous resources documented within their database near Junipero Road and McCall Blvd; additionally, from this intersection, .9 miles is known burials. Waterways near Oak Hursts Ave are highlighted as high sensitivity of buried archaeological deposits. Ms. Nour confirms no grading beyond existing right-of-way. Mr. Macarro highlights the need for monitoring for SCE pole relocation and Ms. Sifuentes agrees and informs Mr. Guillen that during talks with SCE that they do acknowledge this requirement for the Project and that compliance will be the responsibility of SCE.

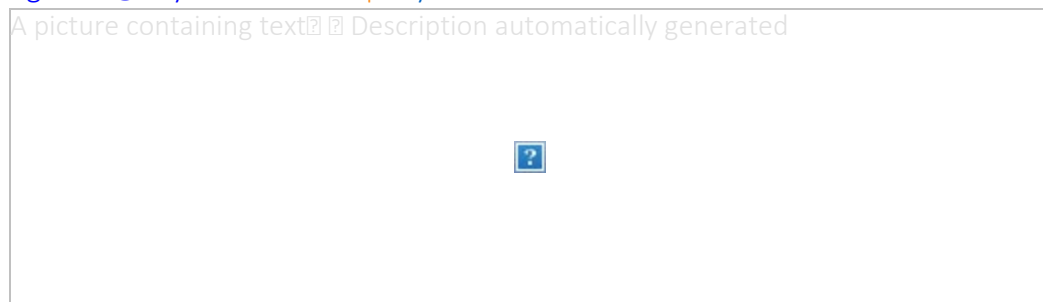

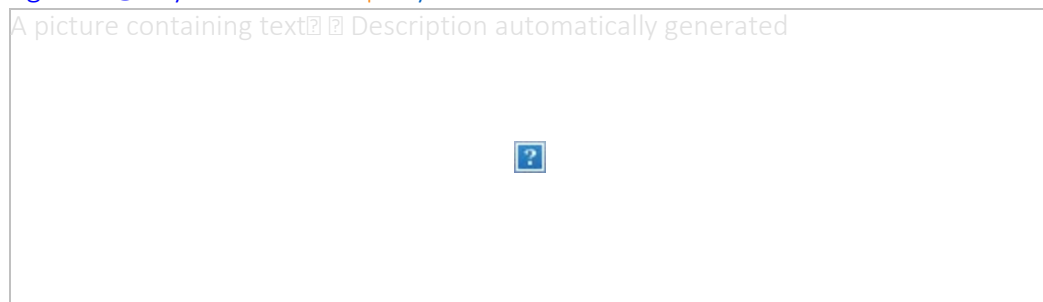
