The Zone Change will designate the reconfigured parcel from Village Commercial (VC) to Highway Commercial (HC). A Major Design Review and Administrative Use Permit are requested for the construction of an ARCO fueling station consisting of a 3,400 square-feet AM/PM convenience store, an automatic car wash, the gas station which will include a 4,606 square-feet canopy, six (6) multi-product dispensers that would create a total of twelve (12) vehicle fueling stations, the installation of three (3) underground storage tanks and associated improvements.
