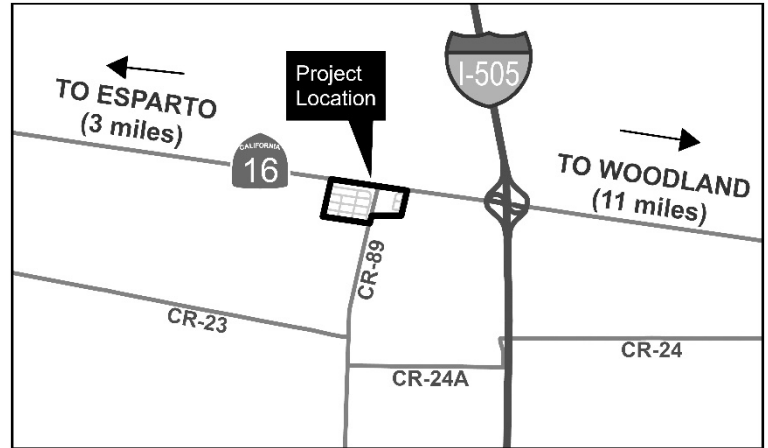


Notice of Public Meeting and Intent to Adopt a Mitigated Negative Declaration

The Madison Community Services District (Madison CSD) has prepared a Draft Initial Study with proposed Mitigated Negative Declaration (IS/MND) to evaluate the environmental impacts associated with a drinking water system infrastructure improvements project. The project would include replacement of underground water distribution pipes and construction of a new water storage tank, booster pump station, and a storage and shop building. The old pipes would be abandoned in place and disturbed areas would be returned to pre-project conditions.

Madison CSD is sending this Notice of Intent to inform responsible agencies and interested parties that the Draft IS/MND is available and to solicit comments and concerns regarding environmental issues associated with the proposed project. Mitigation measures have been identified for Biological Resources, Cultural Resources, Geology/Soils, Hazards/Hazardous Materials, Hydrology/Water Quality, Noise, and Tribal Cultural Resources. As described in the Draft IS/MND, the project would not cause a significant adverse environmental impact with implementation of the mitigation measures.



Project location: The proposed project is located in the unincorporated Town of Madison in Yolo County, California, approximately 11 miles west of the City of Woodland. The Madison CSD treatment system is located at 28963 Main Street, and the distribution system is located along the town's residential streets. The project site is bounded to the north by California Highway 16 and surrounded by agricultural land.

Cortese-listed Sites: The California Environmental Quality Act (CEQA) requires that this notice disclose whether the project site is identified on any of the lists enumerated under Government Code Section 65962.5 (Cortese List) including, but not limited to hazardous waste facilities, hazardous waste property, and hazardous waste disposal sites. No portion of the project site is identified on the Cortese List.

How to view project documents: As the lead agency for the project, Madison CSD released the Draft IS/MND for circulation to interested public and responsible agencies on February 2, 2024 for a 30-day public review period that will end on March 6, 2024.
