Demolition of existing structures and buildings known collectively as the Facilities Management (FM) facility, a complex of 17 structures with a cumulative 44,406 square feet. The project proposal also includes the relocation of the existing vehicle fueling and washing operations from the FM site to a University-owned property located in the Cabrillo Buiness Park in Goleta, approximately .75 miles from the UCSB main campus.


