On State Route 125, in the City of La Mesa, County of San Diego. Maintenance proposes pavement rehabilitation at the Amaya Drive northbound entrance ramp by cold planing the top 0.25-feet of the existing asphalt concrete and replace with 0.25-feet of rubberized hot mix asphalt along the entire width of the entrance ramp. All work will occur within the paved travel way and within Caltrans Right of Way. No ground disturbance will occur. No new right of way required. Any project changes will require further Environmental review.
