The California Department of Transportation (Caltrans) proposes to replace the existing southbound bridge at Toro Creek on State Route 1 in San Luis Obispo County at postmile 32.6. The project proposes to remove the existing southbound bridge structure and construct a new bridge structure in its place. Project activities will involve vegetation clearing, vegetation replanting, pavement removal, pavement repaving, pavement restriping, bridge aesthetic treatments, grading, slope stabilization, erosion control, temporary water diversion, temporary construction access, temporary construction staging sites,
