Project Description: Di Capri Residential proposes to subdivide an existing 7.65-net acre vacant lot into three (3) parcels for condominium purposes supporting 61 single-family units along with 3 common areas and a retention basin. The project proposes a density of 7.97 du/ac. The project includes three (3) architectural elevations (Craftsman, Farmhouse and Spanish) and four (4) unique floor plans that range in habitable area from 1,766 square feet to 2,022 square feet. The project includes approximately 147,141 square feet of irrigated landscaped area.
