Combining (RE-5:AIR) under Title 17 of the Tuolumne County Ordinance Code (TCOC).

Tentative Subdivision Map T20-002 to divide the 82.2-acre parcel into 13 residential lots, ranging in

size from 5.0 acres to 10.07 acres.
