## NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Pursuant to Title 14 of the California Code of Regulations, Sections 15072 and 15073, as amended to date, this is to advise that the City of Palmdale, which is the lead agency overseeing this project, has completed a Mitigated Negative Declaration for the proposed project described below.

**Project No.:** Tentative Tract Map 83359 and Density Bonus Agreement (AGR) 24-0002

**Project Location:** The project is located immediately adjacent to, and south of, East Palmdale Boulevard between 50<sup>th</sup> Street and 55<sup>th</sup> Street East. The Assessor Parcel Number (APN) is 3023-002-184.

**Project Description:** The proposed project would facilitate the development of up to 191 units of single-story, single-family homes consisting of three-bedroom housing units, two-bedroom Accessory Dwelling Units, and one-bedroom Junior Accessory Dwelling Units.

**Environmental Review:** Pursuant to California Resources Code Section 21081.6, a Mitigation Monitoring Reporting Plan (MMRP) will be developed to ensure the implementation of mitigation measures necessary to reduce or eliminate identified significant impacts. The MMRP will be reviewed and adopted by the City in conjunction with the findings required under CEQA.

**Public Review Period:** The IS/Mitigated Negative Declaration (MND) is available for public review and comment pursuant to the California Code of Regulations, Title 14, Sections 15072 and 15073 (CEQA). All comments must be submitted **in writing** to the address below. The comment period during which the City will receive comments on the Initial Study/Mitigated Negative Declaration is set for:

**Ending Date:** March 14, 2024

**Public Hearing:** The City of Palmdale Planning Commission is scheduled to make a decision regarding this project and the associated MND on March 14, 2024, in the City Council Chamber at 38300 Sierra Highway, Palmdale, California, 93550 at 7:00 pm.
