The proposed project is a minor subdivision, Tentative Parcel Map 20188, to subdivide 120 acres into four parcels and a remainder (parcel sizes range from 14.5-acres to 28.5-acres) in the unincorporated Hesperia portion of the County of San Bernardino. The project site is located north of State Highway 173. The County's Countywide Plan designates the project area as Rural Living 5-acre minimum (RL-5). The site is regulated by the Fire Safety 1 (FS1) Overlay, the Bald Eagle (FE) Overlay and the Arroyo Toad (FE) Overlay.
