Demolish approximately 7,900 ft2 of buildings (ceramics bldg & music bldg and approximately 24,500 ft2 of hardscape. The Project involves constructing 32,107 ft2 of new buildings and modernizing the existing kitchen/cafeteria building (Building C). The new permanent buildings would be built in the NE area of the school adjacent to the NE parking lot. Proposed new buildings include an 11,094 ft2 1-story cafeteria-kitchen building, a 9,744 ft2 1-story music building, and a 6,648 ft2 1-story art and ceramics building.
