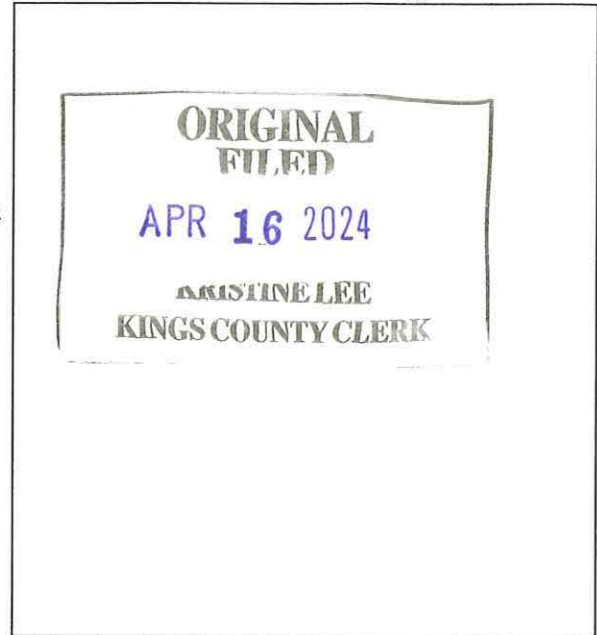

Project Description: The applicant is proposing to construct and operate a biogas facility. The proposed project would include three manure separation systems, underground infrastructure (water, wastewater, electrical, and biogas), an anaerobic dairy digester, and a conditioning plant with biogas conditioning equipment. The digester and conditioning plant would affect approximately 16.2 acres within Assessor's Parcel Number (APN) 044-280-005. Manure separation systems and underground infrastructure would also be installed at the two existing dairies (APNs: 044-280-012 and 044-280-013) and one feedlot facility (APN: 044-280-005).

This is to advise that the Kings County Planning Commission (Lead Agency or Responsible Agency) has approved the above-described project on April 1, 2024 and has made the following determinations regarding the above described project:
