

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Pursuant to Title 14 of the California Code of Regulations, Sections 15072 and 15073, as amended to date, this is to advise that the City of Palmdale, which is the lead agency overseeing this project, has completed a Mitigated Negative Declaration for the proposed project described below.

Project No.: Site Plan Review 20-011

Project Location: The project site consists of one parcel (approximately six acres), Assessor Parcel Number (APN) 3022-026-003, hereinafter referred to as the project. The project is generally located east of Lockheed Way, west of 10th Street East, south Blackbird Drive, and north of East Rancho Vista Boulevard (Avenue P).

Project Description: The proposed project consists of the construction and operation of two industrial buildings totaling approximately 118,200 square feet of building area and associated improvements including, landscaping, sidewalks, utility connections, pavement of parking areas and drive aisles on approximately six acres of land.

Environmental Review: In compliance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines, the proposed development is considered a project and would have to go through the environmental review process prior to approval and adoption by the City. In accordance with the CEQA Guidelines, an Initial Study (IS) was prepared, which determined that while environmental impacts would occur with implementation of the PBP Industrial Project, the environmental impacts would be reduced to less than significant with the implementation of mitigation measures.

Public Review Period: The Initial Study/Mitigated Negative Declaration (IS/MND) is available for public review and comment pursuant to California Code of Regulations, Title 14, Sections 15072 and 15073 (CEQA). All comments must be submitted <u>in writing</u> to the address below. The comment period during which the City will receive comments on the IS/MND is set for:

Review Authority: The City of Palmdale Review Authority is tentatively scheduled to make a decision regarding this project and the associated MND on April 8, 2024.
