Amend Section 28.15, Title 14, California Code of Regulations Regarding California Halibut Daily Bag and Possession Limit Certificate of Compliance

The California Fish and Game Commission (Commission) has taken final action under the California Fish and Game Code with respect to the proposed project, the amendment of Section 28.15, Title 14, California Code of Regulations (CCR).

Categorical Exemptions to Protect Natural Resources

This rulemaking action maintains, restores, and enhances populations of wild California halibut in northern California. The amendment to Section 28.15 reduces the daily bag and possession limit to two fish for California halibut taken north of Point Sur, to safeguard stocks due to fluctuating fishery effort shifts and environmental conditions. The California Department of Fish and Wildlife (Department) requested the change to promote the sustainability of the California halibut population while reducing recreational take, without jeopardizing this popular recreational fishery. Accordingly, the action is exempt from the California Environmental Quality Act (CEQA; Public Resources Code Section 21000 et seq.), pursuant to CCR, Title 14, sections 15307 and 15308 (actions by regulatory agencies for protection of the environment).

The Commission adopted an emergency regulation on May 17, 2023. By this regular rulemaking (certificate of compliance) adopted February 14, 2024, the existing two-fish daily bag and possession limit for recreational take of California halibut in northern California established by emergency regulation is made indefinite.

The project was prompted by the need to extend the existing two-fish bag limit in northern California beyond the one-year maximum time frame provided by the emergency regulation. It is expected that the fishery will require additional time to rebuild following high levels of take caused by an effort shift from salmon and nearshore groundfish closures, and environmental conditions, documented in 2023.

Due to the necessity displayed by the emergency regulation, and interest from the recreational fishing industry for increased stability in the California halibut population, the Commission has determined that the fishery should not revert to a bag limit of three fish north of Point Sur.

Because this project will help maintain, restore, and enhance populations of wild California halibut throughout California, it is exempt from CEQA pursuant to CCR, Title 14, sections 15307 and 15308.
