WHAT'S BEING PLANNED?

The California Department of Transportation (Caltrans) has prepared an Initial Study (IS) with Proposed Negative Declaration (ND) for the proposed U.S. Highway 101 (U.S. 101) Corte Madera Creek Bridge Rehabilitation Project (Project). The Project is located in Larkspur, Marin County, on the Sir Francis Drake Boulevard on-ramp to southbound U.S. 101 at post mile 8.47. The purpose of the proposed Project is to extend the service life of the Corte Madera Bridge by rehabilitating the bridge deck and protecting the bridge columns in the tidal zone of Corte Madera Creek.

WHY THIS AD?

Caltrans has studied the impacts that the proposed Project may have on the environment and has determined that there are less than significant impacts. The IS-ND is the document that explains why the proposed project will have less than significant impacts on the environment. This public notice is to inform you of the preparation of the IS-ND and Section 4(f) Evaluation and of their availability for review and the 30-day public comment period.
