PROJECT DESCRIPTION: The Ordinance would apply zero or low emissions standards to various aspects of industrial commerce center(s), including zero-emission equipment, rooftop solar panels, and environmental compliance measures aimed at mitigating air quality degradation. The Ordinance defines Industrial Commerce Centers as a facility used for storing and consolidating manufactured goods, typically larger than 200,000 square feet with specific characteristics such as dock high loading doors and truck activities. The Ordinance applies to warehousing, logistics and distribution facilities in the City of American Canyon for which a Notice of Preparation is issued after March 1, 2024 under the California Environmental Quality Act (CEQA).
