Project Location: The Project is located at 1735 Barker Creek Rd. in Trinity County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distributor – Transport Only License.

Project Activities:

The Project will consist of utilizing 10,000 square feet (sf) of existing small mixed light tier 1 cannabis cultivation consisting of 7,000 sf of permitted greenhouses, 3000 sq ft of outdoor cultivation utilizing light deprivation, and 1480 sf of processing and agricultural input storage consisting of 2 buildings. A self-transport distribution license is held in conjunction with the cultivation license, and on average two trips per month are required to take product to distributors.
