RESOLUTION No. 24-01 OF THE BOARD OF COMMISSIONERS OF SACRAMENTO RIVER WEST SIDE LEVEE DISTRICT

WHEREAS, the work described in the Sacramento River West Side Levee District (SRWSLD) Flood Maintenance Assistance Program workplan consists of routine levee maintenance to existing levee facilities and falls within the categorical exemptions to the California Environmental Quality Act.

WHEREAS, SRWSLD performs routine maintenance on its existing infrastructure and facilities associated with the District's operations and maintenance responsibilities. These routine maintenances of facilities fall within the categorical exemptions of the California Environmental Quality Act.

WHEREAS, all repair of erosion protection, levee crown restoration, levee section restoration including adding material to back slopes, pipe inspection and maintenance, construction of toe berms, geotechnical explorations, and construction of seepage berms, drains, and other measures to control seepage falls within the categorical exemptions to the California Environmental Quality Act.

WHEREAS, all the work described above falls within the categorical exemptions to the California Environmental Quality Act pursuant to Section 15301 (Class I) of the Guidelines for the California Environmental Quality Act, California Administrative Code of Regulations, Title 14, Chapter 3, Article 19.

WHEREAS, the District finds the proposed work will not have a significant effect upon the environment.

WHEREAS, said work does not constitute an exception to the exemptions of the California Environmental Quality Act.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of SRWSLD as follows:

 SRWSLD hereby directs the General Manager to prepare and file with the County Clerk of Yolo and Colusa Counties and the State Clearinghouse for posting, a "Notice of Exemption" pursuant to California Administrative Code of Regulations, Title 14, Chapter 3, Section 15062. **Passed and Adopted** by the Board of Commissioners of Sacramento River West Side Levee District on the 14th day of February 2024.
