Description of Nature, Purpose, and Beneficiaries of Project: Eugene Lam has submitted a Minor Exception application, requesting to construct a 334 square foot first-floor addition and 547 second-floor addition to a legal nonconforming 1,296 square foot single-family dwelling. The square footage of the single-family dwelling would total 2,177 square feet. In addition, the applicant has proposed a 1,050 square-foot attached accessory dwelling unit that is not included in the Minor Exception application. The project site is located at 3362 Kelburn Avenue (APN: 5287-022-043) and is in the Light Multiple Residential (R-2) zone. The existing single-family dwelling unit is nonconforming due to the existing 3'-11 7/8" side yard setback (minimum 10'-0" side yard required) along the north property line.
