Project Location: The Project is located at 57586 Foster Creek Road, Unincorporated, CA 95454 in Mendocino County

County: Mendocino County

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis nursery license and small mixed light tier 1 license submitted by 3rd Gen Family.

Project Activities:

The Project will consist of a mixed light cannabis cultivation site of no more than 10,000 square feet of canopy and a nursery of no more than 12,000 square feet of canopy. There is no expansion of existing structures, and the cannabis cultivation will be provided with adequate utilities (water and sewer), access roads, drainage, and other necessary facilities. Other public services such as solid waste and public road capacity have been considered and are adequate to serve the project. Water for the project is delivered by R. Skinner Water, which purchases water from the Laytonville County Water District.
