Project Title: Streambed Alteration Agreement No. EPIMS-ELD-47863-R2 (Bits of Things Timber Harvesting Plan 4-23-00158-ELD, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in El Dorado County, within CALWATER watersheds Ice House Reservoir and Carpenter Creek and their connecting tributaries; Township 11N, Range 15E, Sections 4, 5, 8, 10, 11, and 15, Township 11N, Range 14E, Section 12 and 13, and Township 11N, Range 16E, Section 18 U.S. Geological Survey (USGS) Quad Maps Kyburz and Pyramid Peak; Mount Diablo Base and Meridian.

Project: The projects are limited to the use of 14 water drafting sites, constructing and reconstructing permanent low water crossings, and installing a permanent rock-armored fill crossing. Further explanation of work can be referenced within the THP 4-23-00158-ELD.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
