Ordinance 5194 changes the threshold at which an encroachment permit is allowed for work within the County right-of-way from \$100,000 to \$250,000, as well as delegates to the Director of Transportation authority to execute, amend, and accept as complete Road Improvement Agreements for projects with estimated costs between \$250,000 and \$1m.


