The proposed project is located in Nevada County in the area immediately surrounding the City of Grass Valley. The project would update the area known as the City's sphere of influence (SOI). The project designates areas based on existing development, ability for the City to provide services, and the development potential of the area as either near-term sphere, long-term sphere, or as an area of interest (AOI's). Near term sphere areas are anticipated to be annexed to the City within 5 years, and long-term sphere areas are anticipated to be annexed in 20 years. AOI's are not anticipated to be annexed but warrant consideration and consultation with the City should Nevada County take any development actions. This project does not include any proposed development and would not entitle any development.
