**DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT**: The purpose of this project is to remove the old heating and cooling components in the Franklin-Wolfe Variety Store Building in Columbia State Historic Park and replace them with a smaller, more efficient "mini split" unit for the comfort of the concessionaire and park visitors. Work will;

#### Interior work:

- Remove the old heater unit and all accompanying duct work and/or piping;
- Use in kind materials to repair all holes resulting from the removal of the old heater, duct work and piping/vents;
- Cap off and seal vent opening; and
- Dead end any unnecessary wiring and gas lines, and;

## Roof and Ceiling:

- Remove evaporative cooler and heater vent from roof;
- Dead end electrical and water tube; and
- Cap off and seal duct opening with similar sheet metal.

### New Installation:

- Add a 30-amp 240-V breaker to the existing breaker panel and run wiring through new ¾-in. or 1-in. metal electrical tubing from the sub panel to the new outdoor HVAC unit;
- At the rear exterior of the building, install a service disconnect, a pre-poured concrete pad and the new outdoor HVAC unit;
- Install/connect all necessary electrical wiring and tubing from the exterior to along the top of the interior wall in the back room;
- Install a 4-in. by 4-in. wooden chase/cover, attached to the wall to cover the electrical tubing, and paint to match the existing interior wall color;
- Use a vented, wooden box, resting on a loose brick perimeter wall, but attached to the building exterior with slide bolts, to cover the outdoor unit to disguise it from view;
- Install new mini split unit in the interior; and
- Install white fan coil unit to back wall above the bookshelf in the main room;
