The project proposes a culvert replacement along Dinkey Creek Road over Markwood Creek. The replacement bridge will consist of a concrete slab with two 12-foot wide travel lanes and two 4-foot wide shoulders with a vertical limit of roadway construction no to exceed 6 feet in depth. The replacement bridge is proposed to be constructed along a new alignment of Dinkey Creek Road downstream of the existing road alignment.
- 9. Surrounding land uses and setting: Briefly describe the project's surroundings:**  
The project sites are right-of-way located along Millerton Road between Auberry Road and State Route 168. The majority of surrounding land uses include vacant land, grazing land and rural residential uses.

Participating California Native American Tribes were notified of the subject application and given the opportunity to enter into consultation with the County of Fresno on addressing potential cultural resources under the provisions of Assembly Bill 52 (AB 52). Notified Tribal Governments did not enter into consultation with the County of Fresno and did not express concern with the subject application.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation.
