PROJECT DESCRIPTION

SLO County Fire in collaboration with the YTT Northern Chumash Tribe plans to conduct prescribed burning on Sequoia Riverlands Trust conservation lands located in California Valley. The objectives for this project are to increase cultural benefits, biodiversity, and habitat function by implementing prescribed fire. This project will help reduce the number of roadside ignitions and help reduce the spread and intensity of wildfire through the reduction of fuel loading adjacent to traveled roads. This project will also help reduce the spread of invasive non-native plant species and promote native species health and regeneration within the area. Methods will include the use of a mower and hand tools for site prep and ignition devices for broadcast burning beginning in the spring of 2024 and continuing annually based on resource availability. Existing roads and trails will be utilized for control lines to avoid ground disturbing impacts.

An archaeological and biological site review have been completed for this project, records are held at 880 Manzanita Dr, Los Osos, CA 93402. In addition to onsite surveys, a desktop biological review with a minimum one mile buffer was also included for this project area to identify any potential listed plant or animal species present. This included CNDDB, BIOS, RareFind, CNPS, Calflora, and landowner records. As identified this project will not have a significant effect on sensitive plant and animal species.
