Notice is hereby given that the Public Works Department of the City of Perris hereby is considering adopting a categorical exemption for the proposed Landscape Rehabilitation CDBG improvement project, as described below.

CASE NO: Landscape Rehabilitation CDBG Project

APPLICANT: City of Perris

PROPOSAL: The scope is the installation of trees, shrubs, ground cover, and irrigation at an existing developed site.

LOCATION: Generally located on the east side of Perris Boulevard from North of the Cemetery to Citrus Avenue.

ENVIRONMENTAL DETERMINATION: Determine the project is categorically exempt pursuant to the California Environmental Quality Act (CEQA) Guidelines, Sections 15301 (Existing Facility Projects) and 15301 (Existing Facilities), as the proposed Project consists of negligible landscaping improvements to an existing parkway and would not result in significant impacts.
