**Project Location/Address/City/County:** LD 1 Sutter is located adjacent to the west levee Feather River south of Pease Road in Yuba City and north of the confluence of the Feather and Bear Rivers in Sutter County.

**Description of Nature, Purpose, and Beneficiaries of Project:** To authorize the: (1) new levee units within the boundary of LD 1 Sutter, resulting from the dissolution of State Maintenance Area 3 and the annexation of its territory as approved by the Sutter Local Agency Formation Commission under Resolution No. 2023-0003; and (2) assumption of operation and maintenance responsibilities by LD 1 Sutter.

**Reasons Why Project is Exempt:**
