Project Title: Annual Sewer Line Replacement/Maintenance, Fiscal Year 2023-2024

Project Location: City of Orange, Various Locations (please see attached location maps)

Description, Nature, Purpose and Beneficiaries of Project: The project consists of; replacement of 4,200 linear feet of six-inch sewer pipe with eight-inch pipe, replacement of 600 linear feet of six-inch sewer pipe with ten-inch pipe, rehabilitation of 970 linear feet of six-inch pipe with cure-in-place pipe liner and corresponding manhole re-modeling/replacement. In addition, the project includes the installation of approximately 660 linear feet of PVC storm drain pipe and various drain inlets and clean-out structures for surface flow drainage. The scope of work will include, but not be limited to: trenching, the upgrade and/or replacement of sewer mains with vitrified clay pipe, installation of PVC storm drain pipe, the removal and replacement of asphalt concrete pavement with, base material, backfill material, curb and gutter, grate inlets, clean-out structures, concrete pavement, and sewer manholes, conducting a construction survey, striping, and traffic control. The proposed sewer and storm drain improvements will be constructed within the existing street right-of-way.

Reasons why project is exempt: The CEQA Guidelines Section 15301 categorically exempts projects that involve the repair, maintenance, or minor alteration to existing facilities, involving negligible or no expansion of existing or former use. The project is exempt because it involves the upgrade and/or replacement of existing sewer lines that are physically damaged and/or to address an existing capacity deficiency that is identified in the City's approved Sewer Master Plan. The proposed work does not trigger the exceptions to exemptions listed in CEQA Guidelines Section 15300.2 and does not expand the existing use.

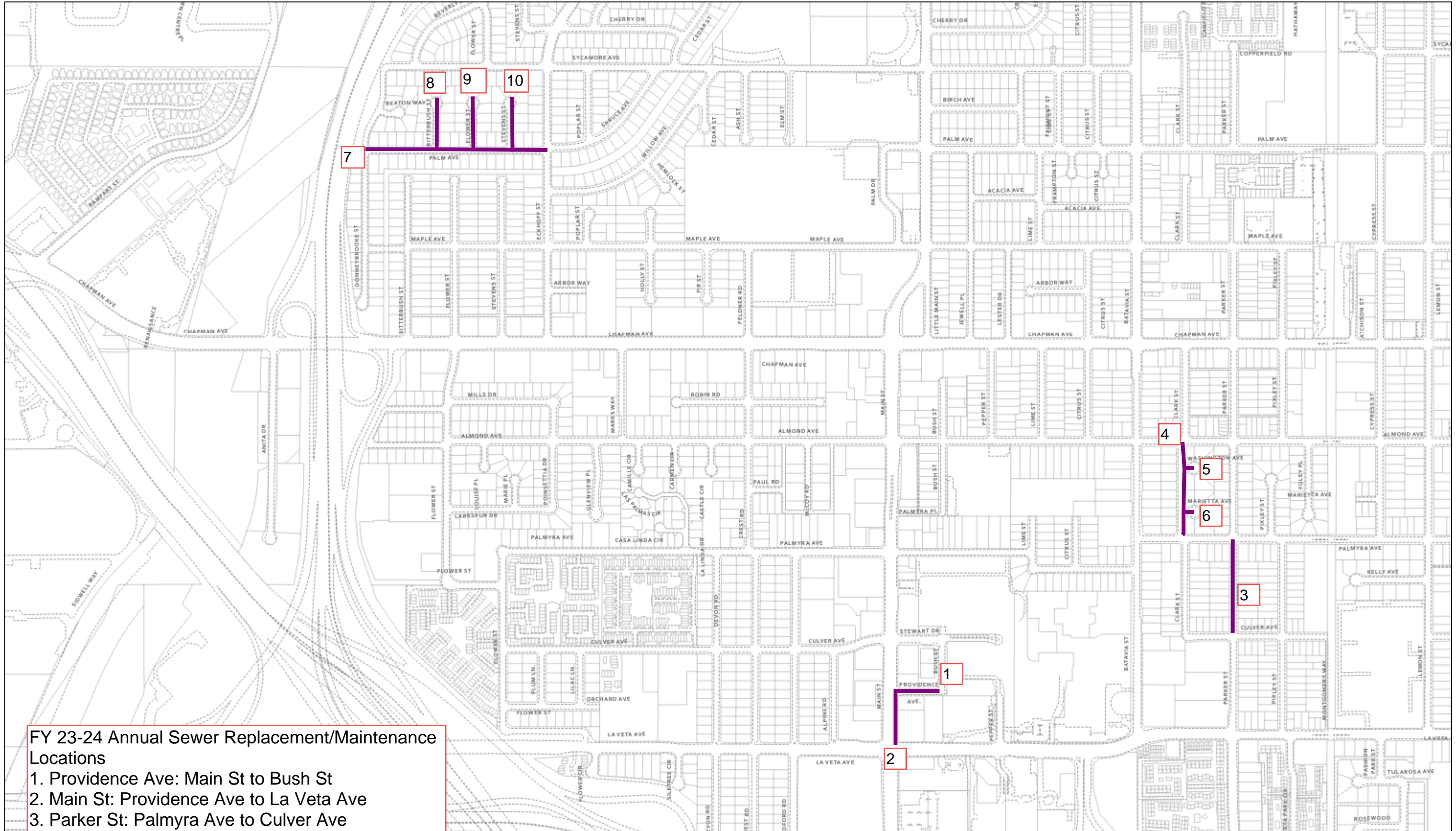

Location Map

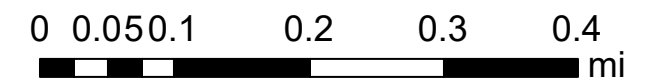


FY 23-24 Annual Sewer Replacement/Maintenance Locations

10. Stevens St: Palm Ave to Cul-de-sac

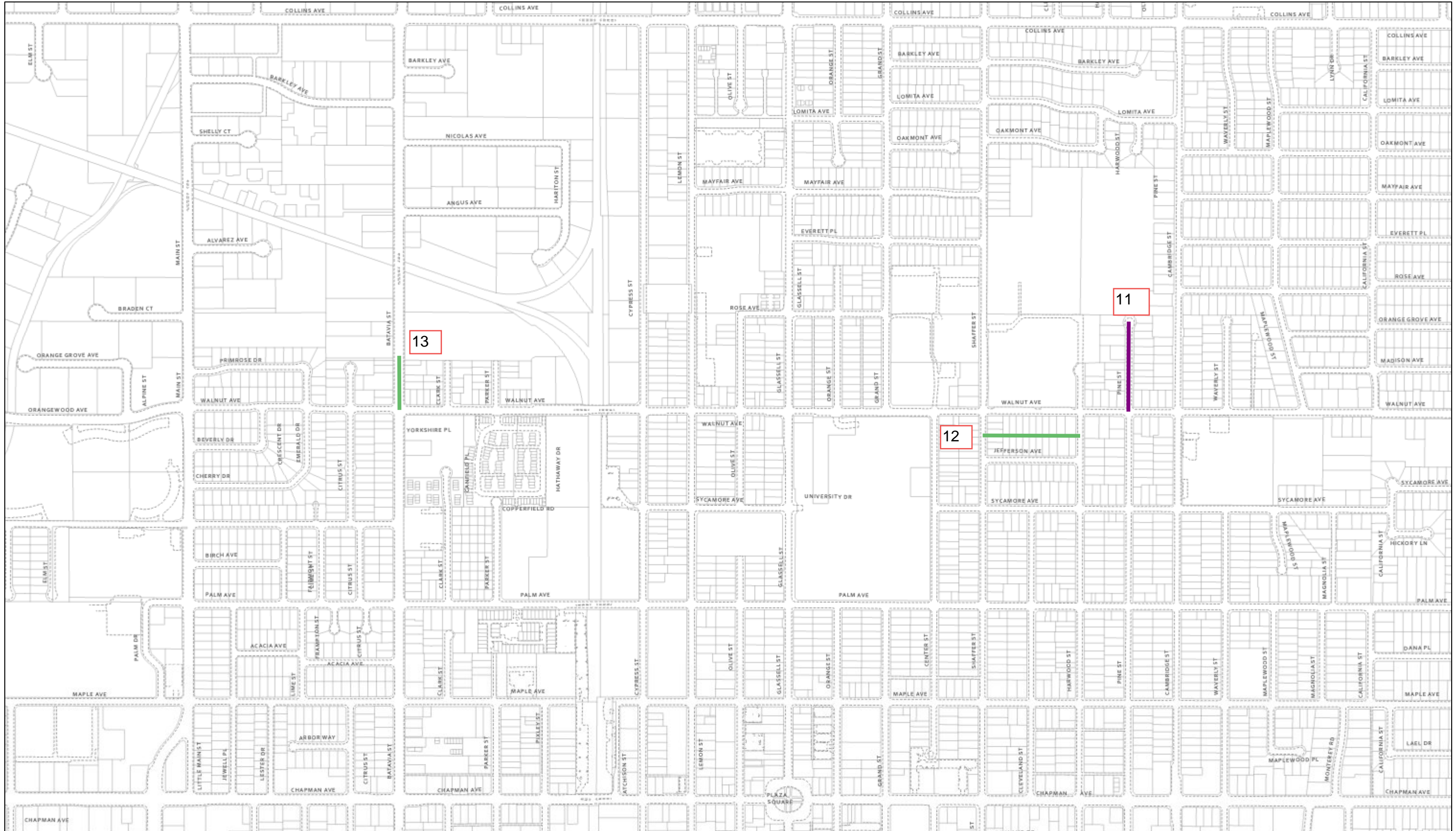

Location Map

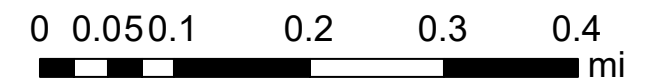


FY 23-24 Annual Sewer Replacement/Maintenance Locations

- 13. Batavia St: Walnut Ave (MH 4131) to MH 4003

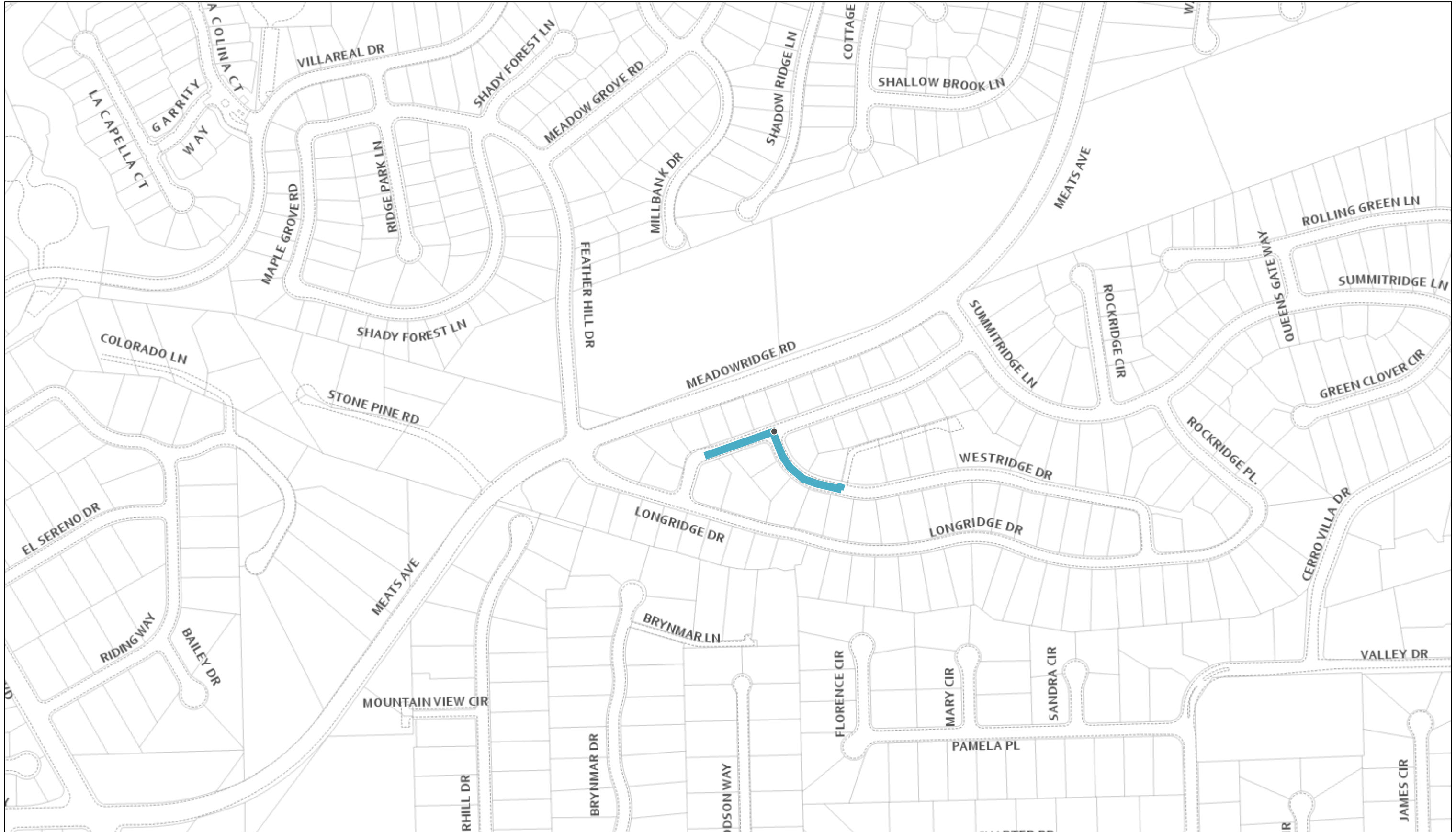

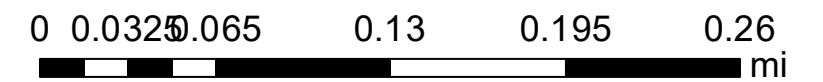
