**Project Title:** Plumbago Road Bridge Replacement (Streambed Alteration Agreement EPIMS Notification No. SIE-46050-R2)

**Project Location:** The project is located at Kanaka Creek, in the County of Sierra, State of California; Latitude 39.464468, Longitude -120.838225; along Plumbago Road near the community of Alleghany in Sierra County, CA; Assessor's Parcel Number: 006-090-002-0.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed an amendment to Streambed Alteration Agreement EPIMS Notification Number SIE-46050-R2, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Sierra County.

The project consists of an amendment to the Streambed Alteration Agreement EPIMS Notification Number SIE-46050-R2 that includes additional information on the quality of habitat in the impacted area to lower the onsite restoration requirement of the Agreement. The amended habitat creation area will consist of three planting areas adjacent to the east side of Plumbago Road on both the north and south side of the bridge, totaling 0.02-acre (1,055 square feet). This will include planting areas of 375 square feet on the south side of the new bridge (PA 1), and 480 square feet (PA 2) and 200 square feet (PA 3) on the north side of the bridge.


This is to advise that CDFW, acting as a Responsible Agency, executed the above-described amendment to Streambed Alteration Agreement on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the mitigated negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was not adopted by CDFW for this project.

- 6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
