Project Description: The project consists of construction of a $\pm 2,982$ Square Foot (SF), two-story, single-family detached residence with a 491 SF deck on an undeveloped ± 2.38-acre parcel zoned R2 (low residential) and within the boundary of the West Hills Subarea of the General Plan. The project site features a slope of \pm 20.5 percent from the public right of way to the proposed house location. The two-story residence will be 30 feet in height above natural grade, as measured to the highest point of the roof, and contains three bedrooms, a detached carport, tandem parking within the driveway, and a deck. The main floor is approximately 1,065 SF and includes an attached 491 SF partially covered deck, with an approximately 1,917 SF lower level that is partially set into the hillside, and includes storage, utility room, and laundry.
