The State Water Board is funding the Project referred to internally as Old Pirate Lane Consolidation Project. The Project includes construction of a 260-foot pipeline extension of an existing watermain located within the right-of-way along the Old Pirate Lane that will connect to the City of Huntington Beach's potable water system. The Project also includes installation of 13 new residential water meters that will tie into the pipeline's watermain, abandon an existing well and the Old Pirate Lane Water Company water system.
