Reasons why project is exempt: The CEQA Guidelines, Section 15301 categorically exempts projects that involve the repair, maintenance, or minor alteration of existing facilities within public right-of-way including "existing highway and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities". The project is exempt because it involves the

maintenance of existing street improvements, does not trigger the exceptions to exemptions listed in CEQA Guidelines Section 15300.2, and does not expand the existing use.




