This project is to infill, grade, and level a reclaimed quarry in two phases over five years to allow for the planting of a 131.58-acre site for agricultural production. Phase one will consist of filling the quarry with 1/3 of the total fill material. Phase 2 will consist of filling the quarry with the remaining 2/3 of the total fill material, which will bring the site to grade. Total fill quantity at the conclusion of the project will be approximately 654,321 cubic yards of fill dirt.
