Not Applicable. The project will occur on street/road surfaces within the public right-of-way.

Description of Project:

The project consists of the placing of conventional asphalt concrete, rubberized asphalt concrete, or slurry seal over the existing pavement. Associated work includes constructing ADA compliant curb ramps, repairing damaged pavement areas, conform grinding, and adjusting manholes. All elements of the project will be within the developed roadway, and no impervious surfacing will be placed over the existing condition. The project will not result in any roadway widening or in the traffic capacity of the affected roads. ADA compliant ramps will replace existing developed concrete sidewalks or ramps.

Exempt Status:

Categorical Exemption (PRC Section 21084; CEQA Guidelines Sections 15300 -15333):

CEQA Guidelines Section 15301 – Existing Facilities

Reasons why project is exempt:

Class 1 consists of the operation, repair, maintenance, or minor alteration of existing public or private facilities. The project would occur within the existing road right-of-way and would not require the removal of structures, vegetation, or trees. The project would result in the continued use of an existing facility with little or no expansion of use and is therefore exempt from the provisions of CEQA.

Section 15300.2-Exceptions

Section 15300.2 of the CEQA Guidelines, Exceptions, provides conditions under which categorical exemptions are inapplicable. Review of the Project indicates that it will not violate any of the exceptions, as described in the following section.

- 1. The project will occur in certain specified sensitive environments or locations;
 - The Project locations will be completed within fully developed roadways within urbanized residential communities. All work would occur within the existing paved right-of-way. None of the roadways have been designated as sensitive environments or locations.
- 2. Cumulative impacts will be considerable because successive projects of the same type will occur at the same place over time;
 - The Project will not be expected to result in significant cumulative environmental impacts. As it stands, the Project will not result in potentially significant impacts. Therefore, no cumulative impacts will result from the Project and successive projects of the same type and at the same place over time.
- 3. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances;
 - There are no known unusual circumstances that will have a significant effect on the environment. Construction of the project will involve earthwork and therefore is subject to applicable requirements by rule such as SMAQMD Rule 403 fugitive dust.
- 4. The project may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources within a highway officially designated as a scenic highway;

The Project locations are not located in the vicinity of a highway officially designated as a scenic highway. The closest state designated scenic highway is River Road/Highway 160. Therefore, the project will not result in damage to scenic resources or similar resources within a highway that is officially designated as a scenic highway.

5. The project is located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; or

The roadways are not included on any list compiled pursuant to Section 65962.5 of the Government Code. Therefore, there will be no impact related to being located on a hazardous waste site.

6. The project may cause a substantial adverse change in the significance of a historic resource.


The roadways do not contain any historical resources.






