**PROJECT DESCRIPTION & LOCATION:** The project is a request to expand operations by approximately 340 acres with the extension of sand and gravel mining and reclamation activities to two (2) properties, identified Sunset Property and Turner Property, which adjoin the existing mining facility. The project site is generally located on the south side of West Sunset Avenue, approximately 0.5 miles west of South Creek Road in the Los Banos area. The project site is identified as Assessor's Parcel Numbers (APNs) 088-070-039, 088-060-079, and 088-070-086 (Turner Property) and 083-210-033 (Sunset Property). The project site is designated Agricultural land use in the General Plan and zoned A-1 (General Agricultural).

PUBLIC REVIEW & COMMENTS: April 8, 2024 – May 8, 2024

The IS/MND is being circulated for a 30-day public review and comment period. Any written comments on the IS/MND must be received at the above address or above email no later than 5:00 PM on the end date of the public review period.
